Tom Clay has been involved in a variety of program development and organizational management. Tom brings a strong work history with him. His current position is Director of Special Projects, Jo Daviess Conservation Foundation where he is responsible for fundraising for special projects as well as protecting land in perpetuity by conducting



outreach to landowners whose properties have been identified as priorities for permanent protection for future generations to enjoy. Tom has held several leadership positions including: Executive Director, Door County Land Trust; Executive Director, Illinois Audubon Society - Illinois' oldest non-profit conservation organization that owns a statewide system of ecologically significant wildlife sanctuaries; and leadership positions in environmental education with Forest Preserve District of DuPage County and the Department of Natural Resources, including committee representation within the International Association of Fish and Wildlife Agencies. George Covington is an attorney in Lake Forest. He was a partner of the Chicago law firm of Gardner, Carton & Douglas (now Drinker Biddle & Reath) for twenty years and chaired that firm's real estate department. Since 1995 he has practiced law in Lake Forest, specializing in land use issues including conservation easements. He is a graduate of Yale University and the University of Chicago Law School. His practice



specializes in real estate law and not-for-profit organizations with a particular focus on conservation easements and related conservation development. He has drafted and negotiated hundreds of conservation easements, ranging from façade easements on downtown buildings such as the Chicago Theatre and Palmolive Building to easements protecting open space and natural areas. He is the author of various articles in professional publications, including Conservation Easements: A Win/Win for Preservationists and Real Estate Owners, published in the Illinois Bar Journal and has spoken at numerous meetings and seminars, including ones sponsored by the Illinois State Bar Association and the Land Trust Alliance. In addition to his service on the Illinois Nature Preserves Commission, he is a member of Lake Forest Open Lands Association and Little Traverse Conservancy, a Michigan land trust. His past service includes being chair of the Student Conservation Association, Illinois Chapter of The Nature Conservancy, Corlands, and the Chicago Academy of Sciences. He also was the finance chair for four of the bond issue referendum campaigns of the Lake County Forest Preserve District. He was married to the late Barbara Trentham, an artist, and is the father of three grown daughters, Karen, Jean, and Sarah.

Marcy DeMauro-Roth retired after a 35-year conservation career that began with an internship in the early 1980s with the Forest Preserve District of Will County. She was later hired by the District as a Natural Resource Manager/Environmental Planner, where she was responsible, in part, for managing lands of ecological quality or restoration potential,



including state nature preserves. Marcy was promoted to various administrative positions within District, and appointed as the Executive Director for nearly nine years until her retirement.
