

PASSENGER BOAT LICENSE APPLICATION

Chapter 625, Article VII of the Illinois Compiled Statutes states that it is unlawful for any person to engage in the business of operating a boat or boats carrying passengers for hire without first having obtained a license to do so.

- The fee is \$50 per boat (make check payable to Illinois IDNR).
- An inspection report must accompany your application.
- You must submit a copy of a valid USCG Operator's License for each operator.
- A license is valid for only one year, or a portion of a year to March 1.
