Mike has been the City Arborist for Urbana, Illinois for the last 26 years. He started with the city 6 years before that as a tree climber. Over his tenure, Mike has managed the community forestry and landscape beautification programs and a countywide multi community Landscape Recycling Center, the first municipal-operated facility established in Illinois. Mike also assists with City planning, ordinance and program development and maintains his public access as the community tree consultant. In the early 90's Mike initiated an ongoing countywide marketing and education campaign that attracted the necessary support for the recycling operation to sustain a selfsufficient "no tax dollar" operation for the last twenty-five years. Mike has created a number of how-to-publications for Urbana and in 1997 in cooperation with IDNR initiated the creation of a statewide educational campaign provide to homeowners consistent answers to common tree questions. The effort resulted in four Illinois regional Tree Growing Guides. Through the support of the Forestry Development Council and the Illinois Arborist Association, Mike and a team of state professionals later compiled the information into one statewide publication titled "Under the Canopy, A Guide To Selecting, Planting, and Caring for Trees In Illinois". On its second edition, 120,000



copies of the Under the Canopy publication have been distributed across Illinois and parts of Indiana, and Missouri and Iowa. A year after the new century, Urbana Mayor Prussing asked Mike to research and address a proposed utility tree trimming tariff. Over the course of the following year, Mike joined 17 municipalities, the Illinois Municipal League and State Legislators to create and in 2002 successfully pass present day utility tree trimming legislation.

Mike has been involved with the Illinois Forestry Development Council for 14 years and in addition to his years at the City of Urbana, has worked for the private tree care industry and the Illinois Shawnee National Forest. Mike has a University of Illinois Bachelor of Landscape Architecture degree, is currently a state-licensed Landscape Architect and an ISA Certified Arborist.

Dr. Hildebrandt has been the Illinois State Urban and Community Forestry Program Administrator for nearly 27 years. Reinee has administered over \$5 million in grants to local units of government for tree ordinances, management plans, tree inventories, tree planting and storm recovery projects. She administers the Tree City USA technical assistance/recognition program raising Illinois second in the nation from 1993 to mid-2010's. IL is currently holding at third in the nation for the number of Tree City USA communities. Under her leadership, Illinois has also ranked 1st or 2nd in the Growth Award. Additionally, she administers the Tree Campus USA program and the Tree Line USA program. Reinee prepares the TCU Newsbits (a weekly to monthly newsletter)., administers the IDNR Urban and Community Forestry Webpages and oversees the IDNR Conservation World Famous and Historic Tree Arboretum. During the Emerald Ash Borer crisis, Dr. Hildebrandt created an EAB poster, an EAB Look Alike Poster, and door hangers of which nearly half a million were distributed.

Past projects have included: establishing five regional urban forestry councils from 1991 to 2010, conducting the "Trees Are Terrific" Arbor Day poster contest with two national winners being from Illinois. Most recently, under Reinee's leadership, Illinois became the first NE US state to create a State-level Urban Forestry Strike Team (UFST) modeled



after the USDA Forest Service UFST This project was done program. in partnership with Trees Forever and the USDA Forest Service. Reinee serves on many committees including CFD Urban and Community Forestry Committee, NAASF State Program Administrator's Storms Subcommittee, Illinois Urban Manual (IUM) Technical Committee and has attended Legislative hearings such as the utility tree trimming legislation. In 2017, Dr. Hildebrandt updated the IUM Tree Protection Standards.

Prior to coming to Illinois, Dr. Hildebrandt taught urban and community forestry and forest and park recreation at the university level for nine years; worked in Extension and Research prior to coming to Illinois.
