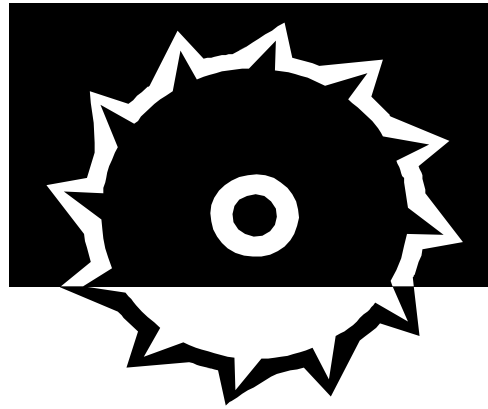

### PLANT TREES ! ... Use quality grown, DNR Native Seedling Stock to reforest sites

Planting tree seedlings after a harvest of timber is an idea dating back to folklore circa Johnny Appleseed! Many foresters, landowners and loggers routinely plant seedlings in a forest when they harvest trees. The best timber species growing in Illinois forests—except for sugar maple and white pine—require lots of good sunlight to

survive and/or grow. It makes sense then to plant when good sunlight is cast to the forest floor via the harvest of mature trees. That makes for good science too and forestry research backs-up the fact that oak and walnut require full sunlight or at least 70% full sunlight to survive and grow.

The IDNR State Forestry Nursery provides exceptionally high-quality nursery stock of most of important Illinois native forest and timber species as well as native shrubs and other plants. The gold standard for reforestation is the 1-0 seedling. Though they are usually bundled 100 to a package landowners, loggers and the public can also get smaller quantities of 25 per package. The state nursery also has pollinator plant seed packets for butterfly gardens or larger pollinator plantings in fields. All materials are affordable and reasonably priced.

The best time to plant is

after the frost leaves for the winter. In far southern Illinois February and March are often the best months to plant. In far northern Illinois it is often as late as April and May. Using northern regions as an example - March planted seedlings do much, much better than May planted seedlings if the ground allows it.

Please remember that delayed planting and unnecessary storage of these live-dormant plants reduces survival and affects their potential growth.

Contact the nursery for updated information and please keep watching the IDNR website for the updated information from the nursery on updates on supplies of certain species. Pages 3 & 4 in this publication contain an order form and ordering instructions.

## **Marked Timber Stumpage Sales:**

This newsletter is posted on the IDNR Forest Resources website monthly. Deadline for each monthly issue is the third Thursday of the month prior. All submissions of marked timber for sale by consulting foresters, procurement foresters or others must be submitted by the second Thursday. Submissions by consulting foresters working with IFDA cooperators must adhere to the timber recommendations approved in the landowner's written management plan. Foresters working with landowners at-large must adhere to recommended silviculture for Illinois forest types. Submissions may be sent US Mail to "ORC-Forestry" at our Springfield office or by email to [paul.deizman@illinois.gov](mailto:paul.deizman@illinois.gov).

**One (1) sale** was marked for cutting by a forester of the Illinois Division of Forest Resources or by a consulting forester or and reviewed by the Illinois Division of Forest Resources. Volumes have been estimated using the Doyle Rule unless otherwise indicated. Deductions have been made for defects. No volume is tallied for culls. Any interested buyers should contact the landowner or their representative directly. The Illinois Division of Forest Resources does not establish the selling price of timber. Buyers must show proof they are licensed.





# NURSERIES - SEEDLING ORDER INSTRUCTIONS

Spring 2018

1. Fill out the order form completely. Incomplete orders will be returned. **ALL ORDERS MUST BE SIGNED.** Orders will be accepted beginning February 1, 2018.
2. Indicate: species wanted; species code; number wanted, and price. Please call the Mason Nursery (309-535-2185) if you have any questions calculating price and shipping.
3. Indicate the County where the seedlings will be planted.
4. Sign, **PRINT YOUR NAME**, address, telephone number. Mail order form to the Department of Natural Resources, Mason State Nursery, 17855 N. County Road 2400E, Topeka, Illinois 61567.
5. **Do not send payment with your order.** You will be billed later. This prevents you from paying for items that may be sold out before we receive your order. After your order has been processed, you will receive acknowledgement of your order. This acknowledgement is also your billing statement with the amount due and a due date. **Please pay by the due date with either a check or money order. Write your order number on your check. Orders will be canceled if not paid for by the due date.**
6. All seedling orders must be picked up at the Mason State Nursery in Topeka, Illinois by May 25. UPS may be available on up to 500 seedlings at a cost of \$25.00/100 seedlings. Indicate if you are interested in UPS shipping. For UPS shipping, please provide a residential address; **UPS will not deliver to a P.O. Box.** All seedlings will be shipped by May 25 unless other arrangements have been made.

The IDNR, Mason State Nursery will make every effort to supply viable plant material that is true to name and size. After the seedlings leave the Nursery we have no control over losses due to shipping, storage, handling/planting methods or weather. Upon receipt of your order, please unpack and inspect the seedlings. Should you have cause for concern you will have 7 days to report problems to us from the date that the seedlings left the Nursery. After 7 days, we will assume no responsibility for damage to stock. If there is a problem with the UPS shipment of the stock the buyer must file damages or losses in shipping with the carrier. Unfortunately, after your check has been deposited we have no way to make monetary refunds.
