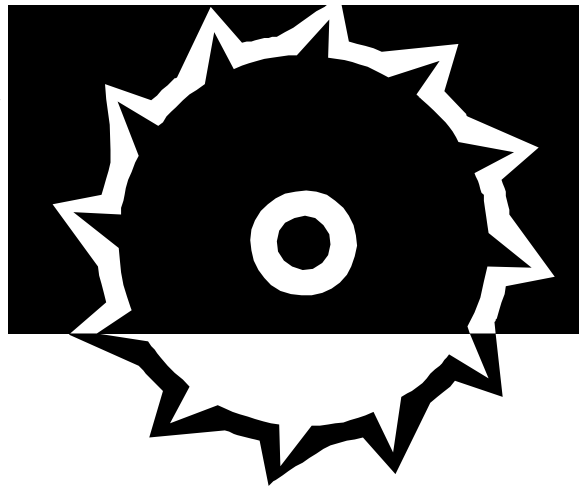

Statistics from Illinois forests show many trends for white oak and walnut. Lots more white grows each year than is cut yet total acreage of young oak is decreasing for the long term due to development, farming and natural conversions of oak forests to maple.

Marked Timber For Sale

Approved postings of marked timber for sale within this newsletter section will be posted on the IDNR Forest Resources website monthly and, if necessary and appropriate, updated mid-month. A submission form is shown below and is required in this format for posting. Deadline for each monthly issue is the third Thursday of the month prior. All submissions of marked timber for sale by consulting foresters, procurement foresters or others must be submitted one week in advance of deadline for review. Submissions by consulting foresters working with IFDA cooperators must adhere to the timber recommendations approved in the landowner's written management plan. Consulting or other foresters working with landowners at-large must adhere to recommended silviculture for Illinois forest types. Submissions may be sent US Mail to our Springfield office or by email attention to paul.deizman@illinois.gov. The forestry division District Forester Field Office map and contact information can be found in this document.

The following timber has been marked for cutting by a forester of the Illinois Division of Forest Resources or was marked by a consulting forester and reviewed by the Illinois Division of Forest Resources. Volumes have been estimated using the Doyle Rule unless otherwise indicated. Deductions have been made for defects. No volume is tallied for culls. Any interested buyers should contact the landowner or their representative directly to satisfy themselves as to the quantity and quality offered. The Illinois Division of Forest Resources does not establish the selling price of timber. Buyers must show proof they are currently licensed under the Illinois Timber Buyers Licensing Act.

The June 01, 2016 issue of Wooden Dollars Monthly was the first issue in since the early 2000s and at the time of publishing of July 01 there was no submissions of marked timber for sale to date. Below is the official format for submissions:

Illinois Timber Buyer Licensing

The Illinois Timber Buyer Licensing Act (225 ILCS 735) requires anyone purchasing timber must be licensed and follow the rules of the act designed to protect forest landowner's. Three Hundred Sixty-five (365) Licensed Illinois Timber Buyers are now licensed in 2016. All are required to report all purchases of standing timber or logs from landowners to the Division of Forest Resources quarterly and assure the landowner's 4% harvest fee is submitted for each transaction.

Illinois Licensed Timber Buyers Directory: Real-Time, On-Line, Searchable PDF

How do I find a timber buyer licensed in Illinois or verify a person or company is a currently licensed Illinois timber buyer or agent? Anyone can do so On-line on the Illinois Department of Natural Resources website on the "Forest Resources" webpage.

There is a real time PDF that is connected to that DNR database of licensed timber buyers that the forestry division maintains. Real time means that when a buyer is licensed or suspended or an agent is added or removed and is entered and saved into the main database; the active real-time pdf is simultaneously updated. The Forestry, Law Enforcement and other divisions now can check "day of" licensing when involved in the sale of timber versus calling a person who must be at a desk to look up a record.

Buyers contact information and bonding amount is listed as well as authorized, legal agents. Any user may click the columns and sort by each column. Users may print sorted pages they choose as well. Users may view the amount of each timber buyers bond held by the DNR as required by the Illinois Licensed Timber Buyers Act.

The Division of Forest Resources must follow mandates of many conservation laws and rules regarding timber though, more important is the actual guiding mission of the Division which is to protect, expand, manage and further forests, forest health and forest products within Illinois. Loggers and mills remain of utmost importance in Illinois and are the true driver for the ability of landowners to profitably manage their forestlands. Loggers quite often work directly with private landowners. The Division of Forest Resources strongly recommends landowners seek professional forestry information and advice on harvesting timber and the health and productivity of their forest. District Foresters in Illinois are available to do that by working directly with private forest owners or referring private consulting foresters who can advise similarly or mark and market an owner's timber. In all cases only licensed buyers and agents may legally purchase timber in Illinois.

U.S. Hardwood Exports To China Rise:
