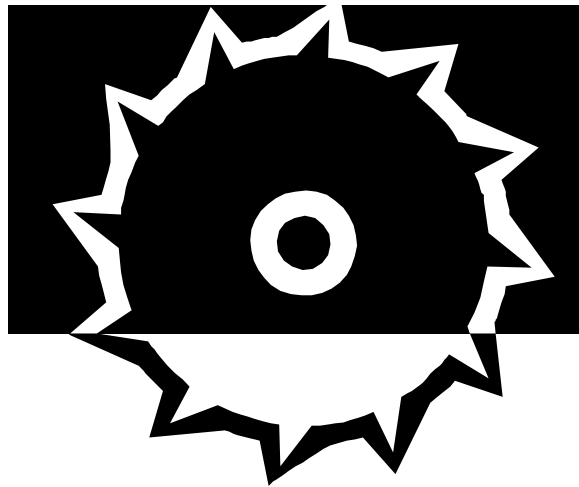

Illinois Timber Price Report: A cooperative effort between Foresters and Timber Buyers!

Since the 1970s the IDNR, then the Department of Conservation, has cooperated with the USDA National Agricultural Statistics Service (NASS) to jointly survey mills and buyers and publish the *Illinois Timber Price Report*. The reports from the past through current are housed with the University of Illinois Forestry Extension website-

statistically sound. Each survey of prices to the nearly 400 licensed buyers and all consulting and state foresters yields results from a fairly low percentage of those reporting. We cannot thank those that do report enough ... for without them there would be no timber price report at all!

A survey for this Summer 2016 for prices paid from May 2016 to August 2016 is being sent next week which will yield the Summer 2016 T. Price Report to be published later this Fall. This latest report (Wint15/16) is attached to this issue of *Wooden Dollars Monthly*. It will be posted on the IDNR and forestry extension websites. See the report for details. Prices are steady to good but down a bit from the two previous reporting periods.

Marked Timber For Sale

This newsletter is posted on the IDNR Forest Resources website monthly. A submission form is shown below and is required in this format. Deadline for each monthly issue is the third Thursday of the month prior. All submissions of marked timber for sale by consulting foresters, procurement foresters or others must be submitted by the second Thursday. Submissions by consulting foresters working with IFDA cooperators must adhere to the timber recommendations approved in the landowner's written management plan. Foresters working with landowners at-large must adhere to recommended silviculture for Illinois forest types. Submissions may be sent US Mail to "ORC-Forestry" at our Springfield office or by email to paul.deizman@illinois.gov.

The following timber has been marked for cutting by a forester of the Illinois Division of Forest Resources or was marked by a consulting forester and reviewed by the Illinois Division of Forest Resources. Volumes have been estimated using the Doyle Rule unless otherwise indicated. Deductions have been made for defects. No volume is tallied for culls. Any interested buyers should contact the landowner or their representative directly. The Illinois Division of Forest Resources does not establish the selling price of timber. Buyers must show proof they are currently licensed or an agent of a licensee under the Illinois Timber Buyers Licensing Act.

Illinois Timber Buyer Licensing:

The Illinois Timber Buyer Licensing Act (225 ILCS 735) requires anyone purchasing timber must be licensed and follow the rules of the act designed to protect forest landowner's. Nearly 400 Illinois Timber Buyers are now licensed in 2016. All are required to report all purchases of standing timber or logs from landowners to the Division of Forest Resources quarterly and assure the landowner's 4% harvest fee is submitted for each transaction.

The Illinois Timber Buyer Licensing Act defines the following:

"Timber" means ... trees, standing or felled, and parts thereof which can be used for sawing or processing into lumber for building or structural purposes or for the manufacture of any article.

"Timber buyer" means ... any person licensed or unlicensed, who is engaged in the business of buying timber from the timber growers thereof for sawing into lumber, for processing or for resale, but does not include any person who occasionally purchases timber for sawing or processing for his own use and not for resale.

"Buying timber" means ... to buy, barter, cut on shares, or offer to buy, barter, cut on shares, or take possession of timber, with or without the consent of the timber grower.

"Timber grower" means ... the owner, tenant or operator of land in this State who has an interest in, or is entitled to receive any part of the proceeds from the sale of timber grown in this State and includes persons exercising authority to sell timber.

FIREWOOD - A Hot Forest Resource



About 2.5 million homes across the U.S. use wood as their primary home heating fuel, a 2.1 percent increase since 2005. About 9 million homes use wood as a secondary heating fuel. Most of the wood used for heating is burned in wood stoves and fireplaces that are commonly used as a secondary heating source yet there is no data on the specific sources of the wood that is burned. Though tens of thousands of cubic feet of wood from trees are specifically removed and used in Illinois each year in cities and farms to heat homes and buildings; there is little specific data within Illinois firewood and home heating statistics either.

Historically Illinois firewood comes from our forests here at home or from the states directly adjacent. Missouri, Iowa, and Wisconsin, for instance, truck a lot of wood to the wholesale and retail firewood markets in and surrounding the Chicago area as well as St Louis and other larger Illinois towns. The Illinois Department of Agriculture, under its pest and plant act, does require an annual firewood importer permit for businesses and producers in an attempt to thwart new invasive insects and diseases firewood can bring.

Since the primary forest product from our forests across Illinois is high quality hardwood sawlogs and veneer logs there is a nearly endless supply of fuelwood from tree crowns usually left in place in the forest. One 24 inch diameter hardwood tree about 50 foot in height yields, in its trunk logs and large branches; 1 standard cord of firewood.

Here are the best firewood species in Illinois and the Midwest. These high rated firewood species all have low spark, low smoke, great heat, and ease of production and use as shown in the next column.

Forest owners should consider harvesting ash before it is infested with EAB or when they first see damage. Contact a forester to determine the harvest suitability and management options for your woodland. If the log market opportunities are missed keep in mind not only is ash one of the best firewood species available—it burns green without the seasoning that oak, hickory and most other species require.
