When the aforementioned project was entered into, its project goals were identified as:

- 1) Recruit resources, coordinate the training, and manage the distribution of eligible Type 2 firefighters to Illinois Department of Natural Resources' Certified Prescribed Burn Managers
- 2) Assist regional certified burn bosses to conduct controlled burns with the goal of enhancing high quality natural areas within the Cache River-Cypress Creek, Larue-Pine Hills-Western Shawnee-Trail of Tears, Eastern Shawnee COA, the Pyramid Arkland Landscape COA, and the Prairie Ridge Landscape COA's
- 3) To have a minimum of 20 qualified Type 2 firefighters on the southern Illinois prescribed fire resource list and to be distributed to state or federal prescribed burns when requested
- 4) Provide annual prescribed fire training applicable for safe and effective fire management activities to anyone wishing to serve as a Type 2 firefighter and be listed as a seasonal resource for southern Illinois prescribed burn managers responsible for using prescribed fire to treat natural areas.
- 5) Utilize prescribed fire to restore natural ecological processes and functions, and to achieve land management objectives on a minimum of 6,000 acres
- 6) Recruit to provide opportunities for a minimum of 70 students and local citizens to become trained and eligible to serve as Type 2 firefighters and create opportunity to supplement income during tough economic times

To date, the project has met and exceeded each of the project goals, as well as exceeding the treatment acres goal of 6000 acres.

Progress on each goal is as follows:

Objective 1: The Shawnee RC&D will recruit resources, coordinate the training, and manage the

distribution of eligible Type 2 firefighters to Illinois Department of Natural Resources' Certified Prescribed Burn Managers.

Completed. Through the course of the project, recruitment was constantly ongoing. Eligible firefighters were referred to our agency by local educators, partnering organizations, and local burn bosses. Shawnee RC&D ensured that all firefighters working at burns were properly certified and eligible to work, and ensured contact information and availability was made available to project burn bosses. .

Objective 2: Assist regional certified burn bosses to conduct controlled burns with the goal of enhancing high quality natural areas within the Cache River-Cypress Creek, Larue-Pine Hills-Western Shawnee-Trail of Tears, Eastern Shawnee COA, the Pyramid – Arkland Landscape COA, and the Prairie Ridge Landscape COA's.

Completed. By not only ensuring a steady supply of qualified, and pre-certified, Type 2 Firefighters, but also providing administrative oversight, Shawnee RC&D made the burn process easier for all burn bosses involved. Because contractor time and pay was handled efficiently, and with minimal work from firefighters or burn bosses, the burn seasons were able to move quickly and accomplish project goals, while still being held accountable for dollars spent. Overall project approval from burn bosses, on this aspect of the partnership was extremely high, with several burn bosses taking the time to send in their thanks to Shawnee RC&D for overseeing the project administration.

Objective 3: To have a minimum of 20 qualified Type 2 firefighters on the southern Illinois prescribed fire resource list and to be distributed to state or federal prescribed burns when requested.

Completed: Use of the online materials and trainings has increased the number of available Type 2 fire fighters (FFT2) to 25-30 regularly available qualifying contractors and more than 60 total firefighters, including those referred by partner organizations.

Objective 4. Provide annual prescribed fire training applicable for safe and effective fire management activities to anyone wishing to serve as a Type 2 firefighter and be listed as a seasonal resource for southern Illinois prescribed burn managers responsible for using prescribed fire to treat natural areas.

Completed: The Shawnee RC&D developed a webpage to guide on-line training.

Field day training was provided by the Illinois Department of Natural Resources. Additionally, many of the registered type 2 fire fighters on this project were recent graduates/students and worked within the SIUC Fire Dawg program, which provides regular and reoccurring training.

All forms were available to be submitted electronically or by mail, for greatest convenience. The Shawnee RC&D and the Illinois Department of Natural Resources have met with local conservation groups, Southern Illinois University, the Southeast Illinois Prescribed Burn Association and the Shawnee National Forest to describe program and recruit firefighters. Program details and employment opportunities have been presented to over 150 students and local citizens.
