IL Habitat Fund Advisory Committee Action

The Illinois Habitat Fund Advisory Committee held their annual meeting on December 17, 2020. The Committee's responsibility is to review and recommend the allocation of funds in the Illinois Habitat Fund.

Summary of Recommendations

The Committee recommends approval of \$250,000 for IDNR habitat projects on public lands, encumbering \$708,000 for governmental and not-for-profits grant projects. The Committee also voted to designate \$176,000 for IDNR future land acquisition. Committee actions are summarized as follows:

Habitat Development on Public Lands - \$250,000

The Illinois Recreational Access Program (IRAP) was recently awarded it fourth USDA Natural Resources Conservation Service Voluntary Public Access Habitat Incentive Program (VPA-HIP) grant in August 2020. This grant will continue and expand this popular hunting and fishing public access program that was created in 2011. One of the key components is the habitat work IRAP implements on private landowners' property they have leased for hunting and fishing access. However, funding for habitat projects was reduced considerably in this latest grant for IRAP. In order to meet demand and further benefit wildlife across Illinois, IRAP needs funding to implement key habitat projects across the state. Currently, IRAP has 24,000 acres under lease and plans to add another 10,000 acres in the next three years to meet public demand and deliverables of the VPA-HIP grant. IRAP will utilize this grant to contract for aerial spraying of bush honeysuckle and various habitat practices outside of the two Habitat Strike teams' boundaries. Practices, such as, non-native species removal, brush management, pollinator and tree prep and planting, timber stand improvement, and others will be implemented on IRAP leased properties.

IRAP currently has an intergovernmental agreement with the Sangamon County Soil and Water Conservation District (SCSWCD) in which its two IRAP Coordinators are housed as well as habitat management contracts are coordinated and implemented. IRAP has a very good 9-year history with the SCSWCD for the coordination and implementation of IRAP since its inception.

Work Area: All habitat work will be on 3,000 IRAP leased acres. Most of this grant will be used for aerial spraying of bush honeysuckle and the remainder will be used to contract habitat work outside of Habitat Strike Team work area.
