- Discussed information about procedure for Plant ESTAC to use to consider changes in status of plant species.
- Presentation by Brian Charles (INHS) on "Revision of S-Ranking for Rare Plants in Illinois". He is part of a team working on these recommendations.
- Reviewed species A-R from North & Northeastern Species List.
- Reconsider Carex intumescens at Plant ESTAC meeting in southern Illinois.
- Need to ask a lichenologist about *Cladonia homosekikaica*.

### 2. Species Recommended for Petition to Change Status.

## A. CHANGE from Endangered to Threatened OR from Threatened to Endangered

- *Amelanchier interior* (Threatened)—Change to Endangered; 9 yes-0 no; Brian Charles will prepare petition.
- *Chamaesyce polygonifolia* (Endangered)—Change to Threatened; 7 yes-2 absent; Eric Ulaszek will prepare petition.
- *Epilobium strictum* (Threatened)—Change to Endangered; 10 yes-0 no; Gretel Kiefer will prepare petition.
- *Juniperus communis* (Threatened)—Change to Endangered; 10 yes-0 no; Eric Ulaszek will prepare petition.

## **B. DELIST**

- *Cystopteris laurentiana* (Endangered)—Delist; 10 yes-0 no; Brian Charles will prepare petition.
- *Rubus odoratus* (Threatened)—Delist; 10 yes-0 no; Brian Charles will prepare petition.

# C. NEW LISTING

- *Carex pallescens*—Add to list as Endangered; 10 yes-0 no; Paul Marcum will find someone to prepare petition or prepare himself.
- *Corylus cornuta*—Add to list as Endangered; 10 yes-0 no; Susanne Masi will prepare petition.
- *Hypericum swinkianum*—Add to list as Endangered; 10 yes-0 no; Gretel Kiefer will prepare petition.
- *Platanthera flava* var. *herbiola*—Add to list as Threatened; 9 yes-1 no; Paul Marcum will prepare petition. (var flava will be added to current P.flava listing)
- *Prunus nigra*—Add to list as Endangered; Matt Evans (CBG) will prepare materials. No vote taken—will consider at a later meeting when have more information.
