Subject: Illinois Habitat Fund Advisory Committee Action

The Illinois Habitat Fund Advisory Committee held their annual meeting on October 26, 2022. The Committee's responsibility is to review and recommend the allocation of funds in the Illinois Habitat Fund.

## **Summary of Recommendations**

Grants to governmental and not-for-profits for Habitat Projects	\$ 666,652.42
Designated for IDNR Land Acquisition from the Endowment Trust Fund	\$ 3,300,650.80

## **Total October FY2022 Committee Recommended Funding**

\$ 3,967,303.22

The Committee recommended designating the excess funds in the Illinois Habitat Endowment Trust Fund, Fund #390, which would be all funds above \$10,000,000 corpus, to be available for transfer to the Illinois Habitat Fund for the purposes of DNR Land Acquisition, as needed, as future parcels become available. Upon the request of the Director, The Comptroller and the State Treasurer shall transfer amounts not to exceed the actual investment income earned from the Trust Fund to the Illinois Habitat Fund from time to time as needed for expenditures from the Illinois Habitat Fund in accordance with appropriations. (ILCS 520 25/20)

## The Committee recommended funding the seven highest scoring grant applications.

- \$ 234,564.62 Pheasants Forever Request to fund six Farm Bill Biologists in NRCS offices working with private landowners on habitat improvements in Eastern Central, West Central, and South East Illinois counties. Match is \$703,873.89.
- \$ 100,000.00 Pheasants Forever Restore approximately 20 wetland basins within prairie grassland habitat in North East Illinois, Eastern Central and West Central Illinois counties. Match is \$215,955.20.
- \$ 34,935.00 Logan County SWCD -Replacement of a high-work-hours 20 year old Drill Planter previously purchased by the Habitat Fund 20 years ago. Match is \$11,645.00.

\$ 55,000.00	Quail and Upland Game Alliance – Request to fund one Habitat Specialist to work with private landowners on habit improvements. Match is \$30,000.00					
\$ 15,700.00	Lake County Forest Preserve – Purchase of prescribed burns tools and supplies for an increased volunteer work force of 55 volunteers working on five forested locations. Match is \$9,511.20					
\$191,452.80	Shawnee Resource Conservation and Development – Oak Forest habitat restoration on privately owned land parcels that includes invasives removal, prescribed burns and forest stand improvements. Match is \$60,000.00.					
\$ 35,000.00	Quail and Upland Game Alliance – Request to purchase a drill planter to be stored in DuQuoin, Illinois for Southern Illinois areas.
