# **Grantee Pre-Qualification Instructions and Resources**

#### Overview

All grant applicants must be pre-qualified to do business with the State of Illinois. To be pre-qualified for a grant award, an entity must: have a current DUNS number (<u>sign up for free</u>); have a current SAMS Cage# (<u>sign up for free</u>); must not be on the Federal Excluded Parties List; and (if the applicant is a non-profit) be in good standing with the Illinois Secretary of State.

- Generally takes 7-14 business days for approval
- May require a notarized letter
- Requires renewal every 12 months

#### Illinois Secretary of State registration

- Required for non-profits only
- Please note that this process may take 2-4 months
