**Objectives of the contract:**

- 1. Three years ICF monitoring- Ground-truthing of the IDNR ICF Habitat Model Survey 10 random sections of land from the model each year.**
- 2. Continue landowner contacts for Mason County Frog Incentive Program.**
- 3. Monitor ICF's in existing Mason County Frog Incentive Program Landowner Contracts.**
- 4. Lead Public Relations Campaign promoting the Mason County Frog Incentive Program.**

**IDNR ICF HABITAT MODEL**

The IDNR ICF Habitat Model has worked out to be a very reliable tool to use in predicting where ICF will be breeding during a wet cycle. I believe the habitat model can be used to judge ICF impacts in areas that ICF have occurred. The only type of breeding pool habitat that the model does not take into consideration is roadside ditch or agricultural ditches. These areas provide nearly 25% of all ICF breeding pool occurrences. Over the years surveys have taken place through Cass, Morgan, Adams, Pike, Green, Lee, Mason and Menard Counties in Illinois using the habitat model as groundtruthing of the model.

**MASON COUNTY FROG INCENTIVE PROGRAM**

During the three year period of this program, 18 landowner contracts were executed, through the Mason County NRCS/FSA Office. Using the Farm Bill Programs CP-23 and CP-9 we were able to sign up 19 different temporary sand ponds and farmed wetlands totaling 182.2 acres in Mason County.

**MONITORING LANDOWNER CONTRACTS SITES AND OTHER ICF SITES 2012**

Seven different nights were monitored for presence/absence of calling ICF's at Landowner sites and other reference sites in Menard, Cass and Mason Counties. Audible surveys were conducted from 19:30 through 01:30 during the night or until temperatures drop below 45 degrees. This year was the strangest season of the five years I have been involved with. Due to the early high temperatures and drought conditions ICF's were only heard from five different sites in Mason County and for only two consistent nights. After those days the weather reached 85 degrees and water temperatures must have raised also, enough to end the breeding season for this year. With the continued drought this spring most all breeding pools did not hold water long enough to have a successful breeding year. Calling males were also down from previous years, with five being the highest number of individuals in all populations encounter. After this year, I have realized how important breeding pool water temperatures are for all spring frog species. During the evening out, even Western Chorus frogs stopped calling due to the high water temperatures. During this season most breeding pool sites from past years were dry and did not have water. Some areas had water but due to low water levels, no vegetation and only a few places had water and vegetation and not even all of those had frogs.

This season no ICF's were documented in Menard County or Conn Pond or any of the other northeast Cass County sites. No ICF's were documented at Sparks Pond this year although conditions looked good and only the wetland restoration along the north side of County Road 2400N had ICF's and for only two evenings. No ICF's were documented from the rubber liner wetland on the Rollo tract.

There is a sand mining operation that operates east of Mason City. This operation obtains sand for Caterpillar steel cast molds in Peoria, Illinois. This operation moves from one farm to another for a few years removing sand and then finally regrading that tract. This year they were operating right next to one of our ICF Incentive contracts. This activity could have a hydrological effect on the surrounding areas. This activity could have a negative impact on our ICF Landowner Program and ICF's. This should be studied to see if this does or does not impact ICF's in that area.


