TOM CLAY (term expires 6/30/2026)

Tom Clay has been involved in a variety of program development and organizational management. Tom brings a strong work history with him. His current position is Director of Special Projects, Jo Daviess Conservation Foundation where he is responsible for fundraising for special projects as well as protecting land in perpetuity by conducting outreach to landowners whose properties have been identified as priorities for permanent protection for future generations to enjoy. Tom has held several leadership positions including: Executive Director, Door County Land Trust; Executive Director, Illinois Audubon Society - Illinois' oldest non-profit conservation organization that owns a statewide system of ecologically significant wildlife sanctuaries; and leadership positions in environmental education with Forest Preserve District of DuPage County and the Department of Natural Resources, including committee representation within the International Association of Fish and Wildlife Agencies. Tom earned a B.A. in Political Science from Western Illinois University and is a skilled communicator, possessing a passion for vibrant and healthy lands.

Connie retired from an exemplary career with the Illinois Natural History Survey as a plant ecologist. In this capacity, she has contributed to a number of programs including: the Biological Survey and Assessment Program, Illinois Tollway Biological Survey and Assessment Program, Natural Resources Conservation Service Ecological Site Descriptions Project, and the Critical Trends Assessment Program that monitored long term ecological health of sites throughout the state of Illinois. Perhaps most relevant to the Commission's work is her experience as a Regional Ecologist for the Illinois Natural Areas Inventory Update – a critical update to a nationally known statewide assessment of high-quality natural areas. Additionally, she serves in volunteer leadership roles with the Illinois Native Plant Society, Middlefork Audubon Society, and The Nature Conservancy's Prairie Grove Volunteers. Connie has a B.S in Animal Science and an M.S. in Forestry from the University of Illinois.



MARCY DEMAURO-ROTH (term expires 6/30/2026)

Marcy DeMauro-Roth retired after a 35-year conservation career that began with an internship in the early 1980s with the Forest Preserve District of Will County. She was later hired by the District as a Natural Resource Manager/Environmental Planner, where she was responsible, in part, for managing lands of ecological quality or restoration potential, including state nature preserves. Marcy was promoted to various administrative positions within District and appointed as the Executive Director for nearly nine years until her retirement. She earned a B.S., Biology from Northeastern Illinois University, and a M.S. in



Biology from the University of Illinois at Chicago. She previously interned with the Morton Arboretum's Rare Plant Conservation Program and was a guest instructor for natural areas management at Northeastern Illinois University. She has published papers on rare plant species inventory, monitoring and management; authored reports to various agencies and organizations on natural areas restoration and management; and authored two federal recovery plans for federally listed plant species. Marcy currently serves on the Board of Directors for The Nature Foundation of Will County and is a volunteer and member of several conservation organizations.

Previously, John served as the Coordinator for Upper Midwest and Great Lakes Landscape Conservation Cooperative, the Assistant Field Supervisor for the USFWS – Chicago Field Office and as the Chief for the Regulatory Branch of the USACE Chicago District. Additionally, he has been deeply engaged in Chicago Wilderness, Hackmatack and Kankakee National Wildlife Refuges, the Millennium Reserve, Brandon Road Interbasin Project, and 30X30.
