Conservation Police Officers are vested with full state-wide police authority and are trained to the highest standards for law enforcement professionals in Illinois.

In addition to these enforcement responsibilities, Conservation Police Officers serve as an important link between the Department and its various constituencies (civic groups, sportsmen's groups, sport shows, etc.). These officers are called upon to assist outside agencies in emergency situations or rescue operations. They participate in the instruction of conservation related statutes to outside agencies, law enforcement organizations, or educational institutions upon request.

#### Northeast Zone / District 2 – ACTING Sgt. Keith Siedsma

#### (Counties: Kane, Lake, McHenry)

#### KANE COUNTY

CPO Kelley and Intern Ryan patrolled Kane County for fishing and boating violations. 2 citations and 2 written warnings were issued.

CPO laffaldano responded to a hunting complaint involving a deceased fawn. The fawn was discovered at Leroy Oaks Forest Preserve and remains under investigation.

CPO laffaldano responded to a second complaint involving unlawful coyote hunting in East Dundee. This investigation, along with multiple coyote dumping investigations are pending at this time.

CPO laffaldano rescued an injured Waxwings bird and transported it to Oaken Acres Wildlife Center. LAKE COUNTY

While conducting a boat patrol on the Chain O Lakes, CPO Winters issued multiple written warnings and educated multiple boaters on various boating violations.

CPO Davis completed foot patrol on the beachfront of Illinois Beach State Park. Multiple subjects were found in possession of alcohol in a restricted area. CPO Davis walked four miles on the beachfront and issued one citation and three written warnings.

CPOs Kelley, Doescher and Davis patrolled Illinois Beach State Park on a hot, busy weekend. Several written warnings were issued for alcohol, pets on the beach and remaining in a closed area.

CPO Reid observed a vehicle on I-355 traveling at a high rate of speed. Traffic was averaging almost 70 mph and the driver continued to pass multiple vehicles on the shoulder, driving in a reckless manner. The driver was stopped and issued citations for: Driving on the Shoulder, Unlawful Overtaking, No Insurance, and Unlawful Transportation of Cannabis.

CPO Reid and CPO Doescher were on a boat patrol on the Fox Chain of Lakes when they discovered a disabled boater in a dangerous location in heavy traffic. The boat was towed to a safer area and CPO Reid was able to fix the boat's mechanical issue and get the boaters back on their way.

CPO Reid responded to a domestic battery incident at the Chain of Lakes State Park campground. A female victim was struck and choked in front of her children. Charges are pending per Lake County States Attorney's Office.

CPO Doescher and Lake County Sheriffs responded to a suicidal person at the state part and assisted this person in getting to the hospital

#### MCHENRY COUNTY

CPO Reid and CPO Semenik were traveling in rural McHenry County when they observed a vehicle speeding 31 mph over the posted speed limit, as they crossed into the Officer's lane while going over a blind hill. CPO Reid turned around to catch up to the vehicle when it was observed passing a vehicle in a "no passing zone" and disregarded a stop sign at approximately 80 mph. When officers finally stopped the vehicle, it was also discovered the driver was using an unauthorized blue flashing light in the dashboard. The driver was

arrested for: Aggravated Speeding, Disregarding a Stop Sign, Disregarding a No-Passing Zone, and Illegal Use of a Blue Flashing Light.

Northeast Zone / District 3 - Sgt. David Wollgast

#### **GRUNDY COUNTY**

CPO Matt Anderson attended a Hunter Safety Course in Morris.

While conducting boating safety checks at a state park in Grundy County, CPO Prasun issued two boat operators a citation for failing to secure a child less than thirteen years old in a personable flotation device. One of the operators was also given a written warning for no safety cut-off switch lanyard.

CPO Honiotes responded to 2 vessel boat accident that occurred at a private club in Grundy County, where one vessel struck another vessel perpendicularly, launching completely over the second vessel and ejecting an occupant into the water. All occupants refused medical treatment. Further investigation is pending.

CPO Honiotes and SGT Wollgast responded to a boat fire on the Illinois River near Stratton Park in Grundy County. 5 people were onboard a recreational vessel when an explosion occurred inside the engine compartment. The initial fire was suppressed by the operator utilizing the onboard fire extinguisher. The fire later re-ignited, at which time all 5 occupants were removed from the boat and relocated to a safe location. No one was injured as a result of the incident. CPO Honiotes and SGT Wollgast successfully recovered the boat, which burnt to the waterline.

KANKAKEE COUNTY

While conducting boat equipment checks, CPO Elliot observed a boater acting suspiciously near Momence. Once contact was made, it was discovered that the Indiana resident had no Illinois fishing license, fire extinguisher, horn or whistle, and lacked the proper number of legal PFDs required. Citation and warnings were issued.

While conducting fishing checks, CPO Elliot spoke with two individuals that he believed were fishing. After one of the subjects denied fishing, it was later determined that he was fishing without a 2021 Illinois fishing license. Citation issued.

**KENDALL COUNTY**

#### WILL COUNTY

While patrolling a state park in western Will County, CPO Prasun encountered campers with alcoholic beverages and cannabis. The offender was issued a written warning for possession of alcoholic beverages on DNR property and possession of cannabis.

While patrolling a state park in southern Will County, CPO Prasun located two park visitors in possession of alcoholic beverages and a third one with a dog off a leash. Each visitor was issued a written warning for the violations.

CPO Prasun responded to and investigated a drowning from a boat at a private lake in unincorporated Will County. The incident is still under investigation.

CPO Prasun responded to a dumping complaint at a state park in western Will County. After a brief investigation, the offender was located and cited for littering in a state park.

While patrolling a state park in southern Will County, CPO Prasun located several park visitors with alcoholic beverages in an area posted as no alcohol. Five visitors were given written warnings for Possession of Alcoholic Beverages on DNR Property and another one was given a citation. One of the visitors was also given a warning for no fishing license. Two of the visitors were also given citations for littering.

After an investigation into an unlawful deer harvest investigation, CPO Prasun issued a hunter a citation for failure to report a deer harvest by 10pm the same day the deer was taken.

CPO Prasun responded to a complaint of a hawk in a backyard. The hawk was caught and later relocated.

While patrolling a southern Will County state park, CPO Prasun arrested a boat operator for Operating a Watercraft Under the Influence of Alcohol. The operator was issued two citations for O.U.I. and written warnings for no sounding device, no fire extinguisher, and no safety cut-off lanyard.

CPO Honiotes attended a youth fishing derby in Will County, at the Forest Preserve District of Will County's Black Road Access to the Rock Run Preserve.

#### Northeast Zone / District 4, Sgt. Josh Mooi

(CPO Farrell, CPO Gates, CPO Gilliam, CPO Hopper, CPO Kater, CPO Kusta, CPO Longley, CPO Vik, CPO Waigand) (Counties: Cook, DuPage)

#### COOK COUNTY

While on boat patrol on the Chicago River CPO Waigand and CPO Kusta conducted several boat stops and performed inspections. One citation for registration violation was issued and four written warnings for no wake violation and equipment violations.

CPO Waigand and CPO Kater received a call concerning a boat accident with one injured individual. CPO Waigand and CPO Kater responded and were able to make contact with both vessels involved. The injured individual was transported to the hospital with non-life-threatening injuries. The investigation is ongoing.

While on patrol at William Powers State Park, CPO Waigand was driving toward the park entrance, when a white Lincoln passed going towards State Line Road. CPO Waigand was flagged down by two fishermen near the office by the entrance. CPO Waigand met with the two fishermen, in which they gave complaints of the driver harassing them and could also be drunk. CPO Waigand immediately turned around and started towards the vehicle on State Line Road. CPO Waigand found the vehicle that just parked near the boat ramp on State Line Road. When CPO Waigand approached the white Lincoln, the two occupants exited the vehicle and proceeded to lean on the trunk of the car. CPO Waigand made contact with the driver and informed them of the complaint. While talking with the driver, CPO Waigand noticed the driver's speech was slurred, bloodshot eyes, and a strong odor of an alcoholic beverage was coming from his breath when he spoke. The driver completed field sobriety tests and gave a breath sample. The driver was arrested for DUI.

CPO Vik Issued 2 citations and 5 written warnings while enforcing boat regulations on Chicago waterways, one for failure to display valid registration sticker and no type 4 throwable PFD on board.,2 wake zone violations, 1 fishing device violation, 1 passenger location violation, and 1 no fishing license.

CPO Kusta was conducting recreational boat enforcement on a Chicago River. CPO Kusta observed a sailboat without valid registration. Contact was made with the boat operator and it was learned the boat was not

registered since 2001. CPO Kusta completed a boat safety inspection and the operator had no flares and no sounding device on board. CPO Kusta issued a citation for the expired registration and written warnings for the flares and sounding device.

CPO Kusta was conducting enforcement on department lands. CPO Kusta cited two individuals for possession of alcoholic beverages in a State Park and issued a written warning for littering. The littering written warning was due to one of the individuals throwing their beer can into the lake to hide the violation.

CPO Kusta was conducting enforcement on department lands. CPO Kusta observed a fisherman and requested his Illinois fishing license. The fisherman was unable to provide a license and CPO Kusta issued a citation for the violation.

CPO Kusta was conducting recreational boat enforcement on a Chicago River. CPO Kusta observed a watercraft without proper registration. Contact was made with the operator and a citation was issued for unlawful operation of an unnumbered watercraft.

CPO Kusta was conducting recreational boat enforcement on a Chicago River. CPO Kusta observed a watercraft without proper registration. Contact was made with the operator and a boat safety inspection was completed. A citation was issued for unlawful operation of an unnumbered watercraft and a written warning was issued for no fire extinguisher.

CPO Kusta was conducting recreational boat enforcement on a Chicago River. CPO Kusta observed a watercraft in violation of a No Wake Zone. CPO Kusta made contact with the operator and conducted a boat safety inspection. CPO Kusta issued a written warning for the violations of a No Wake Zone, unnumbered watercraft, and expired flares.

CPO Kater responded to an accident that occurred on Lake Michigan. The individual was brought to Navy Pier then transported by EMS to the hospital. Two boats were attempting to tie up together and the male's foot became trapped between the boats, this resulted in a near-full traumatic amputation of the big toe on his left foot. CPO Kater is further investigating the accident.

While driving along South Lakeshore Drive CPO Waigand and CPO Kater observed a two-vehicle accident. The rear vehicle had struck the front vehicle. When approaching the rear vehicle's driver the CPOs could smell alcohol. The woman had slurred speech and had wet herself. CPO Kater performed field tests on the woman before arresting her. CPO Sgt. Mooi was on scene and transported the woman to the police department. CPO Kater booked the woman issued the woman 4 citations. There were no injuries from the accident.

CPO Longley conducted a William Powers State Park patrol. CPO Longley issued a citation to an individual for possession of a short Northern Pike. CPO Longley also issued 7 written warnings for sport fishing violations.

Sgt. Mooi was patrolling the 95<sup>th</sup> street boat ramp at Calumet Park in Chicago when he observed a wave runner being operated by a child. Sgt. Mooi stopped the vessel, and inquired of the age of the child, and if he had a boaters safety card. The 13 year old stated he did not. After speaking with the father, it was determined that the child had signed up for the boat safety class, but had not yet finished the course. The father was issued a written warning for allowing youthful operation.

Sgt. Mooi was patrolling Chicago area boat ramps when he observed a boat being pulled into the launch area at Burnham Harbor. The boat had expired out of state registration on it, and the vehicle was registered in Indiana. While speaking with the boat's owner, it was determined he was an Illinois resident, and had applied for registration. A complete boat registration and safety inspection showed the boat did not have an appropriate throwable PFD, and the horn was non-functioning. There was no other sounding device on the vessel. A written warning was issued for the violation.

Sgt. Mooi was patrolling the Chicago River and Lake Michigan when he observed a vessel coming into the lock at a high rate of speed. The vessel locked through, and exited the lock at a high rate of speed, weaving to the left and right. A stop was initiated and the operator was subsequently arrested for operation of a watercraft under the influence of alcohol. He refused to provide a breath sample, and was issued 3 citations and 2 written warnings.

CPO Kater conducted 7 Boat inspections. Wrote 1 warning for unnumbered watercraft, wrote 2 warnings for no fishing license. Submitted DUI Field Report.

CPO Kater Met with Forest preserve officer about woman dumping tilapia and crayfish in Busse Lake, the investigation is Pending.

CPO Waigand met with Coral Reef Pet store owner to issue one citation for failure to keep records on native herptiles bought or sold for at least 2 years. The owner was issued a renewed herp permit from the department and will appear in court later this month.

CPO Waigand met with a home owner in Elk Grove Village to issue a citation for the migratory bird act. CPO Waigand had recent contact with the individual and told him that he could not remove the tree in his backyard until all birds' nests were not active or got a permit from USFW. The individual did not receive a permit with USFW, but a recommendation email for cutting the tree down. CPO Waigand informed the individual that he did not have the proper permit to cut the tree down, and in the process several birds were killed including mallard ducks. The individual will appear in court later this month.

While on routine boat patrol on the Chicago River, CPO Waigand, CPO Farrell, and Sgt. Mooi observed a boat traveling at a high rate of speed heading North on the Chicago River. CPO Waigand, Farrell, and Sgt. Mooi conducted a boat stop on the vessel just outside of the marina. CPO Waigand conducted a vessel inspection, and observed clues of impairment from the operator. CPO Waigand boarded the vessel and conducted field sobriety tests on the operator. The operator was arrested for OUI and released on scene. The operator will appear in court in August.

CPO Farrell was on patrol near the mouth of Diversey Harbor when he discovered five individuals, three adults and two children walking back to their vehicle with fishing gear. When asked to see their fishing licenses it was discovered that one individual did not have a current fishing license. It was also discovered that the group had caught five Yellow Perch that morning (Closed season May 1 through June 15). One individual stated that the children caught the fish and the father was under the impression the closed season did not apply to children. The father was issued a citation and a written warning. CPO Farrell seized the five Yellow Perch.

While conducting boat patrol on the Chicago River and Lake Michigan, Sgt. Mooi was confronted by an individual who identified himself as a police officer. Based on the man's behavior, and the information he

kept coming back to, it struck Sgt. Mooi as odd. An initial inquiry has revealed that the man may no longer be a Police Officer, an investigation is pending.

#### DUPAGE COUNTY

CPO Gates received a complaint regarding a vehicle that struck a family of Canada Geese attempting to cross a road in Aurora. The witness was able to provide a picture of the car. Unfortunately, the picture provided a good image of the vehicle but the license plate is unreadable. CPO Gates reached out to contacts at the US fish and wildlife service in attempts to enhance the photo. CPO Gates also reached out to Aurora police and Animal Control. No reports came into the Aurora Police but Aurora Animal Control did say they picked up a dead Goose in the area the complainant stated- Aurora Animal Control was not sure if deceased goslings were also picked up. The investigation is ongoing.

CPO Gates was at a local park district lake in Bartlett speaking with fisherman when CPO Gates observed a white van drive into the park and dump building material into the park's dumpster. CPO Gates was able to obtain the license plate and contacted Bartlett PD to share the information. Bartlett PD was able to locate the man at his residence and issued the man ordinance violations for unlawful dumping.

CPO Gates responded to a complaint received regarding a gosling with what appeared to be a blow dart in its backside in carol stream. The gosling was taken to the Willowbrook Wildlife Center by local volunteers. CPO Gates spoke with citizens who were in the nearby area, but none reported seeing anyone shooting anything at geese. CPO Gates spoke with carol stream police to inquire about any 911 calls that may have come in regarding the situation, there were none. The investigation is ongoing.

While on patrol, CPO Gates observed two young men fishing at a sub-division pond in DuPage County. CPO Gates made contact with both men and it was determined that neither had a fishing license. CPO Gates was able to educate the new fisherman to the fishing laws and both men proceeded to go online to purchase a fishing license. The men were each issued written warnings for not having a fishing license.
