NOTICE OF INTENT TO SET ALTERNATIVE SURFACE CASING

If the Permittee elects to use an alternative surface casing procedure as authorized under 62 IAC 240.610(b) and 240.710(b) the Permittee Must:

- 1. Notify the District Office for the county where the well will be located.
- Notice shall be given utilizing this form. The form is required to be completed and received in the District Office at least 24 hours prior to the commencement of drilling.
 The Permittee's failure to notify the District Office, as required, of the intent to use an alternative casing procedure will
- 3. The Permittee's failure to notify the District Office, as required, of the intent to use an alternative casing procedure will forfeit the Permittee's option to use an alternative casing procedure and the full amount of surface casing as specified on the permit, is required to be set.

NOTICE

A Permittee's failure to notify the District Office of the intent to use an alternative surface casing procedure, and an alternative surface casing was used, will result in the issuance of a violation and an assessment of a civil penalty. In addition, the Department may revoke the permit and require the well to be plugged.

Permittee may select one of the following alternative surface casing procedures (check the box indicating the procedure to be used)
