

## **Sahara Woods OHV Area Rules and Regulations**

- 1. There will be a \$20 per day, or \$65 four-day fee per recreational off-highway vehicle (OHV), required to use the facility. NO REFUNDS.
- 2. All operators are encouraged to register online and complete all the required documents prior to their arrival. Kiosks are available at the site, however, the operator must complete the documents prior to registration and issuance of a permit.
- 3. Registration-Waiver of Liability form must be completed, printed, and signed in ink. These forms must be submitted along with receipt of payment before unloading recreational vehicles from trailers. All operators must have these documents on file with the park before riding, acknowledging and accepting all responsibility with vehicle usage while on IDNR property.
- 4. Vehicle operators under 16 years old must have a waiver signed by their parent or legal guardian and be under the direct supervision of a person over the age of 18 who has a valid driver's license. **All operators** 16 years old and older must have a valid driver's license.
- 5. Everyone will be required to have a wristband afixed and each OHV will have a sticker permit placed in plain view for the entirety of their pass dates.
- 6. There is a capacity limit of **120** recreational off-highway vehicles per day, which will be issued in a first come, first serve order, and no further registrations will be accepted that day.
- 7. Passengers are only allowed on OHV's designed by the manufacturer to carry a passenger. Riding double on all other OHV's is prohibited.
- 8. DOT approved safety helmets are required for all operators and passengers in designated riding areas unless the OHV has a fully enclosed metal cab or roll bar protection and seatbelts.
- 9. Hours of operation are 9:00AM 5:00PM unless otherwise posted. The riding area will be open to riders Friday thru Monday, May 1 thru January 31, and closed from February 1 thru April 30.
- 10. All OHV's must have working brakes, spark arrestors, and mufflers.
- 11. All users of the park must comply with all posted signs.
- 12. Travel is only allowed on designated trails and shall not damage the natural features of the property. The creation of new trails is strictly prohibited.
- 13. Idle speed is required in all parking areas, not to exceed 5 mph.
- 14. Operators must enter and exit the trail area in the same location the width bollards are located. NO EXCEPTIONS.
- 15. Sound level limits are enforced. Aftermarket products may not exceed acceptable levels (96 decibels) including exhaust systems and/or stereo speakers.
- 16. All OHV's must be trailered to and from the facility; OHV's are prohibited from driving to and from the facility on the roadway.
- 17. All vehicles, including OHV's, and trailers must be parked in designated parking areas and may not be left unattended in any park drive access.
- 18. Unauthorized vehicles, including OHV's, and hauling equipment may be towed at owner's expense.
- 19. Glass of any kind is strictly prohibited on property.
- 20. Operation of a recreational OHV while under the influence of alcohol or narcotics is prohibited.
- 21. Consumption or possession of alcohol in the park is prohibited.
