That total cost is \$349,000, and the Huntley Park Park District for Warrington park trail. Ooh, that is also \$349,000 \$200000 cap grant. Berwyn Park district, the Proksa Park trail renovation. So the grant total for them will be if those all those projects are granted will be a million dollars, and I think the last time I looked we had, I can pull that up here really quick while we're talking too.

So getting our projects together and, and kind of winnowed down for you guys, we haven't quite gotten there yet. Region four, we only have a couple projects for region three. That's for Fox Ridge, Embarass River, and that's phase two. And then the other is still there Spitler Woods phase three, which has been hopefully be I think the last phase of that project. Yes.

And that total cost is 250,000 the grant will be 200000. Region five, we have a lot of projects though in the interest of my time I won't go through every single project slow down there people. Let's go back to region one, which we've got several projects listed, but.

Potentially at least at this point when you get this list, they will still be potential projects. And I think what we'll do is internally we'll set a date deadline by, you know, in the end of next week that we can kind of window down and decide what we really want to present to, and then we'll give you the list and then we can arrange another really brief meeting.

Just to do a Webex for just, you know, a quick, you've seen the list, you approve, and then we can get those started through CERP, the locals in our projects, so if everybody's ok with that, in fact, let's just go ahead and and nd take a motion to discuss today, but knowing that we will get a formalized list and hold another brief meeting to go over that list.

Mississippi Palisades Overlook inspection and repair \$20000. We have several projects listed for some of these sites Mississippi Palace has some other repairing some sentinel bridges, repairs on the high point.

So basically I told all my planning staff, I want to have ten to 15 projects from each region without throughout the state, and I'm going to have, we're going to prioritize those and so we want to do three to four projects annually from each region. So.

You know, I I asked for this big list, so what Amy's rattling off is a whole lot of projects that are coming in, but that's really four or five year program. Right, exactly. I don't know how long it's going to take them to replace me, and so I want to make sure that I have a lot of this in place already going before I'm out the door.

Illinois Beach State Park, which we had an RTP project years ago that we had ended up having to withdraw, so this is good to see that back. Silver springs, several projects. So we'll identify the ones that we're going to fund this year, but at least you can get a snapshot look of, at what we're thinking about and planning for.

Region three, as I said, region five has several projects, biggest one being the RV campground for Sahara Woods. Out of what we're doing and then the what we want to recommend for funding. So like I said, we will get our kind of, by the end of, can we say the next Friday? Hopefully.
