

The Area


Henderson County Conservation Area is a popular retreat for camping and fishing. Located 20 miles southwest of Monmouth and five miles east of the Mississippi River, the 87-acre site includes Gladstone Lake, a 27-acre lake with 1.5 miles of shoreline.


History

The property was purchased by the state in 1961 from the C.B. & Q. Railroad, which had used the area to dredge sand and gravel for use in railroad maintenance. The lake water was used for filling the train's steam engines.

Facilities

Camping: Class C campsites, with tables and grills, completely surround all areas of the lake that have road access. Tent and trailer camping is by permit only for a nominal fee. Group camping is permitted; however, groups of 25 or more need advance permission. Groups must not exceed more than 15 minors, and all pets must be on a leash.







Fishing and boating: The lake contains bluegill, redear sunfish, largemouth bass, crappie and channel catfish. A boat launch area with one ramp is located on the southeast side of the lake. Motors are not allowed; electric trolling only.

Winter sports: Ice skating and ice fishing are permitted on the lake when the ice is thick enough.

Hiking: By hiking the Lake View Trail, visitors can complete their walk around the lake. The trail provides access to that portion of the lake which does not have roads.



Picnicking: Sands Picnic Area is shaded and has an ample supply of tables, grills and a small shelter house. Hand pumps are available for water.

Playground: A small playground area provides an attraction for young visitors.

Not permitted: Hunting, snowmobiling, swimming and wading. No plants or parts of any tree may be removed or damaged.

Hours: The conservation area closes at 10 p.m.

Please: Help us keep the area clean for the enjoyment of all visitors. Put all litter in the nearest available trash container.


